Summary of the proceedings of the Extra- Ordinary General Meeting of Tata Motors Finance Solutions Limited

(IST) with option of Video Conferencing (“VC”) facility. The Company, while conducting the said EGM, adhered to the applicable provisions of the Companies Act, 2013 read with the Circulars issued by the Ministry of Corporate Affairs (“MCA”) with respect to the holding of Extra-Ordinary General meeting through VC/ OAVM, from time to time.

In the absence of Mr. Nasser Munjee, Chairman of the Board, members present at the meeting appointed Mrs. Vedika Bhandarkar to Chair the proceedings which was accepted by her. She welcomed all the shareholders, Directors and other participants. Since the requisite quorum was present, Mrs. Vedika Bhandarkar called the meeting to order.
