- For Pre-Login, customer will have to input OTP and then his contract no.
- For Post Login customer will select the contract from dropdown.

- On E-NACH registration form page, customer will input his bank account details and select the participating E-NACH bank from the dropdown with preferred mode – Debit card or Netbanking.
- Customer will then have to accept the terms and conditions and submit the request.
- Customer will get a confirmation page to recheck the details filled and rectify if incorrect.
- Post Confirmation, customer will be routed to his bank for authentication process. Customer will receive an OTP for authentication as per respective bank process.
- The request will then go to NPCI for verification and success or reject update will be sent back to the customers on the screen.
- On success UMRN no. will be displayed to the customer
- On rejection, it will show the reason for rejection and a SMS will be sent to the customer.

E-NACH Registration On TMF Universe and Customer One App

E-NACH is a service launched by National Payment Corporation of India(NPCI). This facilitates registration of mandates electronically between our bankers of TMF and Customer. This is secured and accurate considering authentication by customer using his credentials electronically.

Currently this process was initiated from Head Office for RTB cases where link was sent to customers for registration.

To further enhance and ease the process we are launching E-NACH registration directly by Customers. **Customers can initiate E-NACH registration process for only E-NACH enabled banks.** Current Live list of E-NACH banks are covered in the next slide.

A detailed step by step process for registration of mandate registration from TMF Universe and **Customer One App is covered in subsequent slides**
