**Sub: Outcome of Board Meeting under Regulation 51 of SEBI (Listing Obligations and Disclosure Requirements) Regulations 2015**

Dear Sir / Madam,

This is with reference to our letter dated October 03, 2022, informing you about the approval granted by our Board of Directors to the scheme of arrangement under Sections 230 to 232 of the Companies Act, 2013 between the Company and Tata Motors Finance Solutions Limited (“**TMFSL**”) and their respective shareholders (“**Scheme**”) in relation to the proposed demerger by the Company of the undertaking comprising its non-banking finance related business to TMFSL.

Also, with reference to our letter dated June 14, 2023 informing that the NCLT *vide* its order dated May 12, 2023 which was published by NCLT on June 15, 2023 has sanctioned the Scheme of Demerger.

1. Transfer of all Listed Securities including Non- Convertible Debentures (NCDs) from the Company to Tata Motors Finance Solutions Limited (TMFSL).
